4. Details of our assessment

On the 8th July 2026, NRW officers carried out a site inspection at the Vale of Llangollen Golf Club. Representatives from the golf club were present during the inspection.

The sewage from the club house and toilet block is treated by a package treatment plant. The wash down area has a separator and the liquids are also treated by the package treatment plant. The solids are tankered out.

There are no alarms present but the treatment plant is checked daily. The blowers were heard to be running on the day of inspection.

The outfall could not be inspected as it is in a culverted section of the watercourse, however, there was no evidence of pollution downstream and the water was running clear.

There is a plan to replace the lids on the package plant during the next service, which is carried out at least once a year.
