3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

Routine monitoring samples were taken on 1st July 2026 by NRW. The results from the sample are provided below:

Ammonia concentration was 36.4 mg/L significantly above the criteria value of 2 mg/L. This has resulted in a C1 failure with the potential to cause **major environmental impact.**

Biological oxygen demand (BOD) concentration was 26.7 mg/l which exceeds the permit maximum limit of 20 mg/l. The BOD result is classified as a C3 failure which has the potential to have a minor environmental impact.

Suspended solids exceedance at 54 mg/L above the criteria value of 30 mg/L. This has resulted in a second C3 failure which has the potential to have a minor environmental impact.

Action: Please investigate the cause of the ammonia, BOD, and suspended solids failures and make necessary changes/improvements to site to bring discharge back into compliance with the numeric limits.

Deadline: Please provide NRW with the findings of your investigation and your proposed action plan by 17 August 2026.

NRW are considering enforcement actions.
