4. Details of our assessment

The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Hafren Dyfrdwy Cyfyngedig's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 03.06.2026.

Non-compliance 1

Condition 3.3.5(a) Monitoring programme (for 3B) should be prescheduled before each calendar year.

Knighton OSM schedule 2026 dates were amended after the end of the calendar year (submitted 12/01/2026).

ACTION: Schedule in advance for 2026.

Non-compliance 2

Condition 3.3.7(b) Monitoring programme (for 3C) should be submitted before the 1st of December.

Knighton UWW schedule dates for 2026 were amended after the 1st of December 2025 (submitted 22/12/2025).
