Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

4. Details of our assessment

I attended the site on 14 July 2026 to undertake an unannounced inspection. Weather conditions were dry and sunny at the time of the visit. Water levels within the watercourse were observed to be low.

The intake was first inspected. The structure was in good condition, and the intake screen was in place with no signs of damage. The hands-off flow (HoF) notch was clear of any major obstructions, and the watercourse was able to flow freely. There was a slight accumulation of gravels and stones above the HoF notch from natural sediment immobilization within the watercourse. However, this accumulation could block flow if left unmaintained. The HoF notch should be kept clear and maintained regularly to ensure compliance.

Action: Please maintain/clear 1m any accumulated debris, stones and brash around the notch to ensure unimpeded waterflow.

There is currently no fish passage easement structure present at the impoundment, despite this being a requirement under Further Condition 9.1 of the permit. However, this matter has previously been identified and addressed under CAR_NRW0045186 as an ongoing non-compliance. The operator is currently taking steps to resolve the issue, and it remains subject to ongoing action.



The turbine house was unlocked at the time of inspection, so we were unable to access the metre, however the hydro scheme was not operating during the visit.

The outfall point was then inspected. The fish screen at the outfall point was in good

condition with no signs of damage.



Abstraction quantities were not assessed during this inspection and will be evaluated separately using Abstraction Returns.
