4. Details of our assessment

On 30 June 2026 myself and Kirsty Allwood attended site on a pre-arranged OSM inspection. The weather was cloudy but dry. We were met on site by the Area Supervisor and Senior Operator, thank you both for your time during the inspections.

We started at the site office with EDM and MCERTs sensors. The site passes all flows through the inlet screen. They then flow round the side of the RBC past the flow and EDM sensors. There were several large sacks of Sodium Carbonate next to the wet well at the end of the sensor run, they were not clarified on site so it is assumed they are for pH balancing.

Flows then pass into the front of the RBC which serves as primary settlement. Flows then pass through the central chamber where they contact the rotating discs. Given the health and safety risks, these were not fully assessed but appeared to be in a suitable condition. There is then a Final Settlement section of the RBC which also appeared suitable.

Flows then pass to the far end of a newly refurbished reedbed where they enter a long trough with v-notch distribution. This did not appear to be distributing evenly and the trough had started to accumulate some solids. It is assumed the reedbed is lined.

ACTION: Please confirm if the reedbed is fully lined.

Flows then enter a chamber with another pipe – the purpose of which is uncertain – which then flows towards the outfall though it was not possible at the time of inspection to identify how this is operating.

ACTION: Provide a site layout drawing/diagram for the works with flows and pathways mapped out.

We then inspected the outfall which appears to be suitable and the storm outfall which again appears to have some rag/residue on the stones beneath it. This is likely due to a high rainfall event not coinciding with high river levels.
