4. Details of our assessment

This compliance review has been undertaken to assess the revisions made to the site's Environmental Management System (EMS) submitted on 4 February 2026. This was in response to the Compliance Assessment Report (CAR) CAR_NRW0048983 issued on 1 December 2025 following a site visit that took place on the 17 July 2025

This review considers changes made to define storage times, capacities, and heights within the EMS.

W1A- 1.1. General management

Permit condition 1.1.1(a) states - *The operator shall manage and operate the activities: (a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints.*

Following a review of the updated EMS submitted on 4 February 2026, page 9 has been revised to include a table detailing waste types, storage locations, maximum storage capacities, maximum storage heights and storage durations. The information addresses the requirements of the CAR_NRW0048983 action issued on 1 December 2025 following the site visit dated 17 July 2025.

Action: *Ensure that waste is stored in accordance with the storage durations, capacity limits, storage height restrictions and designated storage areas specified within the EMS. Compliance with these requirements will be assessed by NRW during future site inspections.*
