4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) to comment upon 2026 Q1 Monitoring Returns.

Q1 Monitoring Returns.

Q1 2026 (January – March) monitoring results were submitted to NRW on 24 April 2026 in accordance with Condition 4.2.3.

Emission Point A1.

Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.2.

No Half Hourly or Daily Average Environmental Limit Values (ELVs) for Hydrogen Chloride, Ammonia, Oxides of Nitrogen, Sulphur Dioxide, Total Organic Carbon (TOC), Nitrous Oxide and Particulates were exceeded during Q3.

Emissions to air (Emission Point A1) for Carbon Monoxide show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.2.1.

Stack emissions monitoring was undertaken in accordance with Condition 3.6.1 during March 2026. All results were below the ELVs.

The Operator reported the following anomalies:

- The plant was offline from 10 - 11 February 2026 for an ash discharge blockage.
- The plant was offline again the 11 - 15 February 2026 due to a tube leak.
- The plant came off twice more for separate incidents of ash discharge blockages on 11 January and 17 February and returned to operation the same day.

Residues.

Incinerator Bottom Ash (IBA) and Air Pollution Control residues sampling was undertaken in accordance with Condition 3.6.1. IBA composition for Q1 remained below the 3% TOC limit at 2.07% in accordance with Table S3.4 of the Permit.

An IBA audit was conducted by NRW on the 10 February 2026. The findings were reported to Operator 2 April 2026.

Performance

Plant operating hours year to date; 2,032 hours.

Waste Returns.

Waste returns have been provided for Q1 as follows:

- Waste Received Q1 – 55,868 tonnes.
- Waste Removed Q1 – 12,870 tonnes.
