4. Details of our assessment

Natural Resources Wales officer Shaun Rees met with Mr and Mrs Davies and their son Aled to carry out a routine audit of the site on the 7 July 2026 at 10:30.

You will be happy to hear that no non compliances were identified on our visit.

A discussion took place during the inspection in regards to a possible transfer of the permit, with a cost of £2,844.00 Please see the link below to assist you in the application of transfer

Another option was discussed, with just the possibility of adding names to the permit for succession planning. As such, where the Operator is just adding names to the permit, we are charging an admin variation of £651.00 but will treat it as a transfer. We will assess the suitability on a case by case basis.

If time recording indicates that the time taken exceeds the application fee, we may charge on a time material basis of £125 an hour. This should still work out more favourably than a transfer fee.
