4. Details of our assessment

On the 2 July 2026 a routine sample was collected by Natural Resources Wales from the sample point of the Sewage treatment plant serving Hidden Caravan park and revealed an exceedance in the following discharge parameter.

Non-Compliances (recorded in summary) Actions to be addressed –

Ammoniacal Nitrogen (as N)

Permit limit 20mg/l

Sample result 21.2mg/l

This result represents a minor breach and has been assessed as a Category 4 environmental impact which has no potential environmental effect.

Please ensure the sewage treatment plant serving Hidden Caravan Park is brought back into regulatory compliance and provide any evidence of works carried out to action this to NRW by the 14 August 2026.
