4. Details of our assessment

An unannounced, routine site inspection was undertaken on Tuesday 16 June 2026 to assess compliance against the Standard Rules SR2008 No 3: 75kte household, commercial and industrial waste transfer station with treatment Permit No: EPR/CB3095FL held by Perdue Recycling Ltd. Present at the time of the inspection were: David Ellar (Natural Resources Wales) and the site General manager (Perdue Recycling Ltd).

The weather was fine and dry.

Previous inspection (CAR_NRW0046403):

The site was previously visited on the 13/02/2025 by David Morgan (NRW). During this inspection no permit breaches were identified.

Permit Breaches:

No permit breaches were recorded during this inspection.

General observations:

Permitted activities:

During the inspection a small trommel was seen operating outside of the treatment building, treating soil and stone waste. The site manager explained that the trommel had only recently been brought on help process the soil and stone more efficiently.

It was noted that the operation and the trommel was small and noise and dust were minimal and the environmental risk was low.

The permit allows use of the trommel, provided the operator meets the operating techniques noted in the permit i.e. that the treatment is inside, unless it's a specified waste (01 01 01, 01 01 02, 01 04 08, 01 04 09, 01 04 13, 02 04 01, 10 11 12, 10 12 08, 10 13 14, 15 01 07, 17 01 01, 17 01 02, 17 01 03, 17 01 07, 17 02 02, 17 03 02, 17 05 04, 17 05 08, 19 12 05, 19 12 09 and 20 02 02). The waste being processed at the time of the inspection was deemed to be a 'specified waste' so use of trommel outside was permitted. It is noted however that the use of the trommel is new to the operator and currently not reflected in the Environmental Management System (EMS). The operator must undertake relevant risk assessments and amend the EMS.

General observations:

Waste Acceptance & Storage:

All waste on site appeared to conform with the list of wastes acceptable by the Environmental Permit. Waste was clearly segregated and waste storage activities were assessed as compliant. The majority of waste was stored and treated inside the building. Some specified waste was stored outside in the yard in line with the requirements of the permit. These wastes were namely mixtures of concrete, bricks, tiles and ceramics (EWC 17 01 07) and soil and stones (EWC 17 05 04). Non-specified wastes were stored and treated inside the building.
