Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

This compliance report is the result of a site visit carried out by NRW on 20/07/2026.

Arrived at site and met with MOTO staff. The purpose of this visit was to inspect the now redundant site treatment works and discuss permit surrender.

MOTO have said that the site has now been connected to the new DCWW / Persimmon pumping station and no longer discharges to the local watercourse via its onsite treatment works. This was completed on 01/07/2026.

The discharge from the site has been isolated at the top of the sewer. NRW inspected the final effluent chamber of the site's treatment works which looked to be dry, indicating it is no longer in use. NRW request that photo proof of the site's isolation be provided for confirmation.

Discussed the permit status of the site going forward, which MOTO stated that they are currently looking to apply for a permit surrender alongside the decommissioning of the treatment works. NRW request that MOTO keep us updated with the permit surrender process and site status.
