4. Details of our assessment

Site report

On 29th April 2026 inspections of various Combined Sewer Overflows in the catchment of the Porthcawl beaches were taken in advance of the 2026 bathing water season. The weather was bright and dry. In attendance were 2 Environment Officers from Cwm Taf and Bridgend Environment Team and 2 DCWW pollution technicians and Catchment Performance Manager.

This report is for the asset named Broadlands Area A2 Pumping station, permit ref BP0278401. This permit allows the discharge of sewage effluent under emergency conditions only. It is not a storm overflow discharge.

The inspection of the asset did not raise any concerns. DCWW stated there have been comms failure issues with the asset due to it's location, but this is dealt with quickly. There is a 2 pump set up, one duty pump and one standby by pump. No evidence or record of any recent discharge.
