4. Details of our assessment

CSO at Beach Road (BW3200301)

Site Report

A site inspection of the CSO at Beach Road was conducted on 29/04/2026. This formed part of the 2026 pre-season bathing water inspections. Compliance against permit BW3200301 was assessed. A NRW Environment Officer and Senior Environment Officer were accompanied by a DCWW Catchment Performance Manager and two Pollution Prevention Technicians. The weather was dry and clear at the time of the visit.

At 10:20am access was provided by DCWW to the CSO inspection chamber located at NGR SS 83707 76958 as described in S3.4 of the permit. EDM monitoring equipment was in place and no discharge was occurring at the time of the inspection. DCWW staff explained that monthly cleaning/maintenance is undertaken for the asset. A screen was present with minimal debris meaning the CSO was compliant with section 2.3.1(b) of the permit (*photograph 1*). The asset appeared to be working as designed.

There are no limits on the permit for the number of spills permitted per year. EDM data from 15/05/2025-15/05/2026 showed a total of 7 block-counted spills from the asset, the last of which was on 15/12/2025.

The outfall location was checked at NGR SS 83766 76900 as per S3.2 of the permit. No discharge was seen at the outfall and there was no sewage detritus present. The outfall was partially blocked with sand although effluent could escape through the upper part of the flap valve (*photograph 2*).

The flap valve at the outfall was broken at the hinge at the time of the inspection. Although this was not impacting any operating technique listed on the permit you may wish to consider a repair or replacement.
