General Management -W1A

Under **condition 1.1.1 (a)**, on site operations are required to be conducted in line with a written management system that identifies and minimises the risks of pollution, including those arising from operations, maintenance and accidents.

The permit, current EMS and Fire Prevention and Mitigation Plan (FPMP) were made available on request and held in the office, they are currently held in digital format. As discussed, it is a requirement that all members of staff who's duties are affected by the permitted operations have readily available access to these documents as required under **condition 1.1.3**.

Under **condition 1.1.4**, the site is required to comply with the requirements of an approved competency scheme.

Action - Please provide evidence of the above.

Waste Operations - W2A, W2C and W2D.

Permitted activities undertaken during the inspection were in line with the conditions of the permit. With wastes being stored in the manner described in **conditions 2.3.1** and **table 2.3**. With all wastes stored within separate containers on impermeable surfaces with sealed drainage prior to collection.

All waste operations were being undertaken within the permitted boundaries as required under **condition 2.4.1**.

Emissions and Monitoring - W3A

There was no evidence of any non-compliances with **condition 3.1.1** of the permit during the inspection.
