4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following an unannounced inspection of the 2 Sisters Food Group Sandycroft facility on 13 July 2026 in response to several odour complaints received over the weekend and during the morning of 13 July.

The NRW officer attended the site at 09:50 following an external odour assessment around the site boundary. No odour was detected on Chester Road or Glendale Avenue. A slight odour was detected on Rectors Lane, west of the site, at approximately 09:48. No odour was detected at the site entrance or within the staff car park.

On arrival, the NRW officer joined the Environmental Manager, H&S Manager, and Engineering manager on an odour monitoring round in response to complaint reference WIR2607491, received at 08:58. The site personnel had completed an external odour assessment immediately prior to NRW's attendance. A slight odour was detected in the gantry area where blood and feather collections are undertaken. The feather trailer was being loaded at the time and its cover had been temporarily removed. All other roller shutter doors were closed, dolavs were fitted with lids, and no deficiencies likely to result in off-site odour emissions were identified.

The inspection route included the Effluent Treatment Plant (ETP), where the balancing tank replacement works are ongoing. NRW had previously been notified that replacement works would commence during the week beginning 6 July 2026 and that cleaning and disinfection activities could result in temporary odour impacts, with mitigation measures including the DI-OX odour suppression system being used where necessary.

At the time of inspection, the previous tank structure had been removed and the replacement unit was awaiting installation. No odour was detected from this area, and site representatives advised that the structure had been cleaned and decontaminated in the preceding days.
