4. Details of our assessment

CARS form generated following site visit to inspect Portmadog Holiday Camp limited foul waste system.

A Natural Resources Wales (NRW) Officer attended Portmadog Holiday Camp Limited at 12:50 on 15 July 2026 to inspect the foul sewage treatment system operating under Permit CG0387101. The inspection was undertaken with the assistance of the Site Director, who provided an overview of the treatment process, operation, and maintenance arrangements.

The sewage treatment plant comprises a **Rotating Biological Contactor (RBC)** system. During the inspection, the RBC unit was examined and found to be operating satisfactorily. Upon lifting the inspection cover, the biological discs were observed to be clean, with no excessive build-up of sewage solids or faecal matter present within the system. The plant appeared to be well maintained and in good operational condition.

The Site Director confirmed that the treatment system is subject to regular operational checks and is serviced annually in accordance with maintenance requirements.

The permitted discharge to ground was also inspected and was found to correspond with the location specified within the environmental permit.

At the time of the inspection, no signs of non-compliance or operational concerns were identified.

NRW would like to thank the Site Director for their cooperation and assistance during the inspection.
