4. Details of our assessment

This was a pre-planned audit carried out by a Natural Resources Wales environment officer. The weather was dry on the day of the inspection.

General Observations

The site is a Sewage Treatment works that processes residential and trade effluent. The permit for the site is for the discharge of secondary treated sewage effluent with nutrient removal, the discharge of settled storm sewage, the discharge of storm sewage and the discharge of sewage in emergency .

The officer was taken through the works from the inlet, through the treatment system, before finishing at the final effluent sampling station. The discharge point was not seen due to access issues and the remote location but the final effluent appeared to be clear at the sampling point.

The Process

There is a storm overflow present at the inlet of the works, storm flows then enter the storm storage tank which is within an old primary settlement tank, this was not overflowing at the time of visit. There is both a mechanical screw press and back up bar screen present at the inlet.

The effluent is initially settled in the primary tanks before going through the HYBACS system and then into the aeration lanes. From here further treatment is achieved via sand filters and a final settlement tank.

No non-compliances were identified during this visit.
