4. Details of our assessment

On 05/03/26, officers from Natural Resources Wales (NRW) attended Rag Worm Farm to undertake routine sampling of the site's trade effluent discharge. Samples were collected from both the inlet and outlet sampling points.

Condition 14(a) of the environmental permit requires that the difference in Biochemical Oxygen Demand (BOD) between the inlet and outlet sample points must not exceed 2 mg/l.

Analysis of the samples collected on 05/03/26 identified an increase in BOD of 2.22 mg/l between the inlet and outlet points.

This result constitutes a breach of the permit conditions and has been scored accordingly.

Please provide NRW with an explanation outlining the reasons for this non-compliance by 30/04/26.

UPDATE 08/04/26

Telephone call with Katie Lee (Horticulture Supervisor). At the time the sample was taken, the pump was not operational due to being blocked with sand. Access to the pump was also restricted as it requires crossing Ministry of Defence (MoD) land. The pump has since been cleared and has been fully operational since 17/03/26.
