4. Details of our assessment

The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer following a pre-arranged installation visit on 23rd July 2026. The purpose of the visit was site familiarisation and to follow up on Improvement Conditions IC 6, 7 and 8 in the latest variation of permit number EPR/FP3031CW V005.

A brief initial meeting was held with the Safety, Health and Environment (SHE) Manager and various other responsible managers on site. The overall FMC operation was explained along with the general management of this particular site.

General Management

The EHS Manager explained the history of the site and site operations in general. He spoke about the company trialling a new management system covering safety, maintenance, inspections etc, but added that it would depend on the current trial being conducted on sites in north America. There is no intention at this time to gain the Environmental Management Systems (EMS) ISO14001.

Improvement Programme

The Improvement Conditions (IC6,7&8) were discussed. The operator had provided evidence to support the signing off of:

IC6 - On-site emergency procedure to include potential incidents on the nitric acid tank and associated equipment. This was supplied to NRW via email in May 2026 and fulfills the requirement of IC6.

IC7 - Maintenance regime in the tank farm area. Some of this was supplied in the email mentioned above, but detail on gutter and drain inspections were missing. The Maintenance Manager was requested to show these inspections via their current maintenance management system (CMMS). Having seen their system and the documents supplied in May, the operator has provided sufficient evidence that IC7 has been complied with.

IC8 - A process description of the Safety Instrumented System (SIS), concerning the filling process on the nitric acid tank. The Maintenance Manager provided access to these documents via the CMMS, but the latest updated version of the filling process could not be found. A flow chart was supplied, and this was further backed up with an explanation of the SIS while stood at the nitric acid tank and filling point on the tank farm.

Action. The operator is to supply a copy of the latest procedure to NRW by 10th August 2026, prior to IC8 being signed off.

The Site

The Regulating Officer was shown the whole site (relevant to permitted activities), no issues of concern identified.

Permitted Activities

All observed permitted activities were conducted in an organised and clean environment relevant to the activity.
