4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment of the annual reports and Q1 and Q2 waste returns and closure of Action from CAR_NRW0050837 for Martin Road Hazardous Waste Transfer (Shield).

Quarter one 2026 Waste Returns

The waste returns for quarter one (January – March) 2026 were received on the 20th of April 2026. A total of 13.46 tonnes was received and 13.3 tonnes removed during this quarter. All wastes are compliant, and the report is accepted.

Quarter two 2026 Waste Returns

The waste returns for quarter two (April – June) 2026 were received on the 22nd of July 2026. A total of 13.38 tonnes was received and 14.05 tonnes removed during this quarter. All wastes are compliant, and the report is accepted.

Action from CAR NRW0050837:

Provide a root cause for the late reporting as per permit condition 4.2.2 and a plan of action to ensure that annual reports are submitted as per the permit.

NRW received a root cause from Shield on 5th March 2026 advising that the late reporting was due to the EPR annual reporting date being misaligned with the PRTR annual reporting date. Shield have advised that an action has been put in place to ensure that future reoccurrence of late EPR reporting is prevented.

This action is considered closed.

The above mentioned amendments to the EMS will be verified during NRW's next visit to the Shield Environmental site.
