4. Details of our assessment

Natural Resources Wales (NRW) has completed a review of the Noise Impact Assessment (NIA) entitled “*Noise Assessment for NRW Permit Compliance for Gavin Griffiths Limited*” dated 21 October 2024, submitted in response to Improvement Conditions IC01 and IC02 associated with Environmental Permit **EPR/CB3297ZG**.

The NIA was reviewed by NRW's Air Quality and Noise Team (AQNT) under reference **C841_WD01**.

AQNT concluded that the assessment was undertaken using the methodology specified within the Improvement Conditions and in accordance with **BS4142:2014+A1:2019**. The assessment considered the nearest identified sensitive receptor and modelled noise impacts from the permitted activities, including a worst-case operational scenario.

The AQNT review concluded that the assessment demonstrates no significant noise impact at the assessed receptor. The submitted assessment predicts a rating level of 55 dB, representing a 2 dB increase above background sound levels at New Lodge Farm, and concludes that site activities do not result in significant adverse noise effects.

Having considered the findings of the AQNT review, NRW is satisfied that the submitted Noise Impact Assessment meets the requirements of Improvement Conditions **IC01** and **IC02**. AQNT's review identified no issues that would prevent NRW accepting the Noise Impact Assessment.

Whilst reviewing the assessment, AQNT identified two matters where supplementary information would assist NRW's understanding of the assessment and its conclusions. These matters do not affect NRW's acceptance of the Noise Impact Assessment but require clarification from the operator.

Actions

Action 1

Provide confirmation of the current planning status and authorised use of the nearest property known as New Lodge Farm, including confirmation of whether the property is currently in residential use, office/commercial use, mixed use, or another authorised use.

Action 2

Provide the calculations, assumptions and methodology used to derive the sound power levels assigned to plant and equipment within the Noise Impact Assessment, including any supporting calculations relied upon by the consultant.

Conclusion

NRW accepts the submitted Noise Impact Assessment as satisfying the requirements of Improvement Conditions **IC01** and **IC02**. The Improvement Conditions are therefore considered complete. However more information is still required.

The actions detailed above are requests for supplementary information arising from the

AQNT review and do not affect NRW's acceptance of the Noise Impact Assessment.
