4. Details of our assessment**Reporting of Emissions to Water (01/01/2026 to 30/06/2026)**

This Compliance Assessment Report (CAR) has been completed following assessment of the six-monthly emissions to water monitoring return submitted by The First Milk Cheese Company Limited for Haverfordwest Creamery, Pembroke Road, Merlins Bridge, Haverfordwest, Pembrokeshire, SA61 1JN, operated under Environmental Permit EPR/XP3830UR.

Monitoring returns assessed

The following monitoring return has been assessed:

- Reporting of emissions to water (other than sewer) and land for the period 01 January 2026 to 30 June 2026.

Compliance assessment

Table S4.1 of Schedule 4 of Permit EPR/XP3830UR requires monitoring results for emissions to water from emission point W2 to be reported every six months, with reporting periods commencing on 1 January and 1 July respectively.

The operator submitted the six-monthly Water 1 return on 17 July 2026, in accordance with permit condition 4.2.2. The return was submitted using the agreed reporting format (Form Water 1).

The monitoring data submitted for emission point W2 has been assessed against the emission limit values specified in Table S3.2 of the permit. All reported parameters were within their respective emission limit values. **No exceedances were reported during the monitoring period.**

Permit variation

Permit variation EPR/XP3830UR/V007 was issued on 17 July 2026. No changes have been made to the emission limit values, monitoring or reporting requirements for water discharge emission point W1.
