4. Details of our assessment

This was a pre-planned audit carried out by Natural Resources Wales Environment officers. The weather was dry and sunny on the day of the inspection and for over a week prior to the inspection.

General Observations

Officers were taken through the works from the inlet, through the treatment system, before finishing at the final effluent sampling station, the discharge point was not inspected due to the distance from the site and the access.

The site is a Sewage Treatment works that processes residential effluent and has telemetry in place for monitoring. The permit for the site is for the discharge of secondary treated sewage effluent.

The Process

The flows enter the works at the inlet where all flows pass through a macerator. The flows then enter into a primary settlement tank, through a large filter bed and then to the final settlement tank. The filter bed arms were moving freely and unhindered at the time of the inspection but there was a lot of algal growth clumping and clogging the surface in some areas. The filter bed has recently been fitted with a metal brace to hold the concrete panels together, this has prevented the walls from leaking, this was something that was picked up in a previous inspection. The final effluent appeared to be clear.

No breaches were recorded during this inspection.
