3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 22/06/26, an NRW officer visited Maesteilo Mansion to collect a routine effluent sample from the sewage treatment plant serving the site.

The sample was found to contain:

- 73.7mg/l Biochemical Oxygen Demand (BOD) against a permit limit of 20mg/l.
- 38.4mg/l Ammoniacal nitrogen against a permit limit of 15mg/l.
- 67mg/l Suspended solids against a permit limit of 30mg/l.

These results are a permit breach and are scored accordingly.

Environment Officers attended the site on 21/07/2026 and met with the registered manager who showed NRW the sewerage system on site. We discussed the sample results which he was going to follow up with the maintenance department to investigate.

Please investigate the cause of these exceedances and update us on your findings by 31st August 2026, including a plan on how these exceedances will be prevented in future.

As discussed during the visit, there have been further exceedances other than the results noted above, these will be noted in separate CAR forms.
