4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Hugh Martin of Natural Resources Wales accompanied on site by operators.

The purpose of the inspection to assess the ongoing progress of the actions and requirements identified in the previous inspection and detailed in CAR_NRW0051703.

During the inspection, it was noted that some improvements have been made to the storage practices on site with a slight reduction of waste stockpiles, however there is still a significant volume of waste on site that is stored against the methods described in the Environmental Management Systems and Fire Prevention and Mitigation Plan.

As discussed on site, these are still breaches of **conditions 1.1.1a** and **3.4.1** of the environmental permit, however these have been marked as ongoing **Category 2** breaches as works are still progressing as required.



Action - Condition 1.1.1a - review the current EMS to ensure that suitable management systems are in place that ensure ongoing operations are carried out within the conditions of the environmental permit and identify and minimise the risk of incident occurring through operations.

Conditions 3.4.1 - Ensure that all wastes are stored in accordance with the methods described within the approved FPMP

At the time of the inspection, works had begun on reinstating the collapsed roof at the rear of the building. One completed, wastes will be able to be stored in the bays directly below, which should provide significant storage capacity once completed.
