4. Details of our assessment

Arranged site inspection undertaken by Michael Edwards and Hugh Martin of Natural Resources Wales, accompanied on site by permit operator and external consultant.

The purpose of the inspection was to determine the operators compliance with the conditions of a Regulation 36 notice.

All wastes were removed from the gap between the neighbouring operations with clear separation between both sites and all wastes stored within the boundary of the permit as required under the notice..

A new Environmental Management System (EMS) has been also been submitted as part of a permit variation.

The requirements of the notice have been deemed to be completed.

As discussed on site, there is now a requirement under the conditions of the permit following the operator led variation to operate in line with an approved Fire Prevention and Mitigation Plan (FPMP). This is currently being assessed and you will be written to separately regarding the outcome and suitability of the submitted plan.

Currently the site is undergoing an expansion that will allow the offices to move and increase the space available for the storage of wastes to be in line with the submitted FPMP. With works beginning to improve the infrastructure of the yard.
