3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

A routine final effluent sample collected from the Package Treatment Plant (PTP) serving Properties 1-21 at Nantcribba Barns, Forden by Natural Resources Wales (NRW) on the 27 May 2026 was found to contain 167mg/l Biochemical Oxygen Demand (BOD) and 46.6mg/l ammoniacal nitrogen. Condition 3.1.2 of permit BB3993ZC states that the final effluent shall not contain more than 20mg/l BOD and 5mg/l ammoniacal nitrogen. As both parameters were more than twice the permitted maximum limits, the breaches have been categorised as category 1 non-compliances. Category 1 non-compliances represent non-compliances that have the potential to have a major, serious, persistent and/or extensive impact or effect on the environment, people and/or property.

An Environmental Permitting Regulations 2016 Regulation 36 notice to comply with permit conditions was issued to the permit holder, Nant Cribba Barns Management Company Limited, on the 20 April 2026. Schedule 1 of the notice outlined a number of steps for the permit holder to complete to bring the site back into compliance with permit BB3993ZC. These steps have not yet been completed. In response to the latest permit breaches, NRW therefore ask the permit holder to complete the steps within schedule 1 of the Regulation 36 notice dated 20 April 2026 by the **23 July 2026**. The permit holder should be aware that failing to comply with the Regulation 36 notice is an offence and may result in legal action being taken against the company.

Please note that this Compliance Assessment Report (CAR form) was originally issued to the permit holder on the 16 July 2026 and included a category 1 non-compliance for a suspended solids failure within the same final effluent sample collected on the 27 May 2026. This non-compliance has since been removed as it has been confirmed that the analysis of suspended solids started outside the specified holding time. The result cannot therefore be used for compliance purposes. No issues occurred with the analysis of BOD and ammoniacal nitrogen.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
