4. Details of our assessment

This Compliance Assessment Report has been raised by NRW following a routine site inspection at Eni UK's Point of Ayr Gas Terminal.

Present were representatives from Eni UK (Eni), Saipem (Eni's appointed contractor) and NRW. A brief introductory meeting was undertaken, where Eni and Saipem provided an update on the current status of site operations.

A brief walkover of the site was completed to contextualise the changes on site, the remediation works, water treatment arrangement and future enabling work activities.

The weather on the day of the inspection was very warm and dry, with a gentle breeze; it is understood that this is typical of the weather experienced for several weeks preceding the visit.

NRW officers noted significant changes on site, with the majority of the above ground structures, gas management and distribution infrastructure no longer present. Temporary contractor facilities were in place and operational. The site was clean, tidy and well managed. Road sweepers and water misting cannons were being utilised and were being used in operational areas of the site.

The water treatment system was witnessed and operational at the time of the site visit; but throughput is currently only from surface water and groundwater ingress into shallow excavations. Deep excavation works had not commenced at the time of the site inspection.

Bird deterrents were in place and appeared effective in minimising birds nesting in operational areas. Where birds had successfully nested on the site, exclusion zones were present to minimise unnecessary disturbance of the nesting areas.

Nesting birds remain in the vicinity of the outfall holding basin. This is preventing plant movement to undertake desilting and cleaning prior to it being utilised for the discharge of treated water via the outfall to Talacre Brook. In the meantime treated water is temporarily discharged via overland pipe directly from the fire pond, as agreed with NRW.

NRW officers inspected the treated water discharge location at Talacre Brook. The discharge was flowing at a slower rate than the agreed maximum discharge rate as expected given the dry conditions. There was no apparent olfactory or visual evidence of contamination in the discharge water, nor was there any apparent indications of siltation or scour at the discharge point.

Recommendations

The potential for re-using the treated water for road sweeping /dust suppression instead of using mains water was discussed. It is recommended that the proposal is submitted in writing to NRW for consideration at the earliest opportunity.
