4. Details of our assessment

Rhyd Ddu Wastewater Treatment Works was inspected on the 28th of July 2026.

The site is gravity fed, services a population equivalent of 167, and was in good condition on the day of inspection. The site is visited weekly by an operative and reports no issues.

The outfall could not be seen due to overgrowing plants, and it was noted there are branches above the works that could fall and interfere with the operations. There are plans in place to clear these, DCWW is waiting on confirmation from the landowner.
