4. Details of our assessment

On 9th July 2026 myself and Frankie Farrell attended site on a pre-arranged OSM inspection, the weather was hot and sunny in a period of hot weather. We were met on site by the Area Supervisor and Senior Process Scientist, thank you both for your time during the inspections.

Construction workers were still onsite, though paused operations while we undertook the inspection. We were advised most of the work now was to alter the existing 'temporary' pipework, to fixed, permanent pipework now that the site was operating as designed.

We started at the inlet, flows enter 'Tank 1' where they are dosed with Ferric, before weir-ing over into 'Tank 2'. Flows are then pumped up to the SAF unit based on level controls. Flows then go through the adjacent Lamella unit before discharging via the Sample point.

The outfall was not inspected as it is a significant distance from the site and not on land owned by DCWW.

For incident WIRS2604010 from April '26, the supplied storyboard detailed that the manhole covers for the wet-well were to be changed from a two-person lift to a one-person lift. During the inspection it was noted this has not yet been updated, please let me know when this has been actioned.

ACTION: Update NRW once wet-well chamber covers swapped.
