4. Details of our assessment

This was a routine review of data carried out by Malcolm Dines (Waste Regulation Officer) following the deadline for submitting a report into the Approach To Limit result for VOCs reported in the stack emission monitoring for your site for 2025, as required by compliance report CAR_NRW0051735, dated 11 May 2026.

Permit Breaches

W1A - General Management - Category 3; Permit Rule 1.1.1(a)

You have been given the above breach of Rule 1.1.1(a) as you have failed to comply with a compliance action required by compliance report CAR_NRW0051735. You were required to submit a report investigating why the 2025 stack emission monitoring result for VOCs was Approach To Limit.

The failure to comply with actions required by compliance reports means that you are either not complying with your management system, or that it is inadequate.

Rule 1.1.1(a) requires that you operate in accordance with a written management system that identifies and minimises risks of pollution, including those arising from nonconformances. Your management system must also include a process for recording any non-compliances and the measures you will take to ensure compliance is restored in the shortest possible time.

Action: Submit the records of the non-compliances set out on Compliance Report CAR_NRW0051735 and the measures taken by the company to ensure compliance is restored in the shortest possible time **by 30 August 2026**

If you are not satisfied with the outcome of the stage 1 review, you may request a **Stage 2 appeal**. This request must be submitted **within 21 working days** of receiving the response from the stage 1 review.
