Staff Competence and Training

Evidence of environmental awareness training was not available during the inspection.

Action: Ensure relevant staff receive appropriate environmental training covering:

- Environmental permit requirements;
- Pollution prevention measures;
- Accident and emergency procedures;
- Incident response and reporting requirements.

Training records should be maintained and made available for inspection. Please provide evidence of completed training to NRW by 30 Octo 2026.

Accident Management Plan

The Accident Management Plan did not contain an up-to-date drainage plan.

Action: Review and update the Accident Management Plan to include:

- A current drainage plan;

Dirty Water Drainage Infrastructure

During the inspection, dirty water drains were observed without covers and contained accumulations of manure, feathers and eggs. Appropriate measures should be implemented to minimise the risk of debris entering the drainage system, leading to blockages and potential pollution.

Action: Install suitable covers on dirty water drains and ensure drains are regularly cleaned and maintained to ensure they remain clear and functional by 30 September 2026.

Feed Storage Infrastructure

Feed bins were observed without reflectors, bollards, barriers or other protective measures. Damage to feed storage infrastructure could result in feed spillages and an increased risk of pollution. Appropriate measures should be in place to minimise the risk of accidental vehicle impact.

Action: Install suitable protective measures, such as reflectors, on all feed bins by 30th August 2026.
