4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q2 2026 monitoring and waste returns.

Q2 Monitoring Returns - Air

The site has installed a new bag filter plant and consequently emission points A1 and A12 have been replaced by A17.

The Q2 monitoring returns were received on 30th July 2026 for emissions from A13 and A17 emission points in compliance with permit condition 4.2.3. Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.1.

The result for VOC's on emission point A17 was 19mg/l, approaching the emission limit value (ELV) of 20mg/l. This is significantly higher than results in 2025 and may need investigation to prevent a potential breach of this ELV in the future.

W1 - water emissions

No water was discharged during this quarter

Q2 Waste Returns

The Q2 waste returns were received on 30th July 2026 for wastes accepted for the quarter April to June 2026 within the timescale stipulated in permit condition 4.2.5. The waste returns were reviewed and there were no issues identified.

Bi-annual monitoring of emissions

The biannual data was submitted on 30th July 2026 in accordance with permit condition 4.2. Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.1.
