4. Details of our assessment

This was an announced site visit made by Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the Standard Rules Environmental Permit EPR-FP3097EZ.

Weather was clear with recent long periods of hot sunshine being noted.

Previous inspection:

No permit breaches were observed during the last inspection dated 23/02/2024. Please see Compliance Assessment Report CAR_NRW0043695 for further detail.

Permit Breaches:

No permit breaches were observed during this inspection.

General observations:

The site was generally very clean and well organised, with good segregation of waste types and good waste storage practices were observed.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

The Site (W2D):

All specified waste sections were kept separate and site was well maintained. The site itself in well maintained and clean, however stock levels are higher than usual due to recent hot weather preventing hot works being done. Please ensure that stock and waste levels continue to be in line with requirements defined in your FPMP. The interceptor is routinely checked and emptied by a 3rd party, with the drains being accessible and clear. Depollution area was clear and in use, waste tanks from the depollution process are routinely emptied by a 3rd party.

Reporting (W4B):

Up to date EMS and Site Permit were readily accessible on site. Latest Waste Return Notes up to date, evidence showing up to Q2 2026 has been submitted.

Technical competence:

The TCM for the site holds the appropriate WAMITAB certification. The latest certificate was available on site, expiry date on Continual Competency is 12/12/2027.
