4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a pre-arranged site inspection of the installations facility.

The two water abstraction permits were also reviewed during this inspection and recorded on separate CAR forms.

The site provided an update on recent activities and plans for the future. The site has just started demolition of the PM1 building which will include removal of the related emission points listed in Schedule 3, Table S3.1. An application to vary the permit will be submitted to remove these emission points although there are no associated emission limit values for them.

A steam silencer has been fitted to the yankee pipe vent, the steam generator silencer is due to be fitted this month and the silencer for the 3 boilers is due at the end of this year. This links back to a noise complaint received on 2nd June 2024.

An update was provided on the work being undertaken on optimising the effluent treatment plant (ETP) following a breach of suspended solids in Q1 2026. The cloth filter trial was not successful and the site is continuing to work with their nutrient supplier to optimise the ETP and also with another company to review the whole system.

The site was clean and tidy with no issues.

Groundwater monitoring

A groundwater monitoring report was submitted to NRW to comply with permit condition 3.1.3. on 5th August 2026. The requirements of this permit condition have been incorporated into the site EMS on the Environmental Schedule which was viewed during the inspection.

Q2 2026 Monitoring Returns

The Q2 monitoring returns were received on 20th July 2026 for discharges from W1 and W2 emission points in compliance with permit condition 4.2.3.

All reported parameters were in compliance with the emission limit values (ELV's) applied by permit condition 3.3.1, Schedule 3(b).
