We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

Thank you for your time and cooperation during the recent site inspection undertaken in relation to the new permit for Block A, Flats 1-14, Casita.

During the inspection, it was identified that the flats continues to be served and discharge sewage to the existing septic tank on site. However, the current environmental permit only authorises the use of a **package treatment plant** by the permit holder, **Britannia Homes 2 Limited**, as specified under:

- **Section 2 – Operations**
- **2.1 Permitted Activities**
- **Schedule 1 – Operations, Table S1.1 Activities**

As the development is currently operating using the septic tank rather than the permitted package treatment plant, the site is **non-compliant** with the conditions of the permit.

To address this matter, please provide, by **7 September 2026**, a proposed timetable for the installation and commissioning of the package treatment plant and the cessation of use of the existing septic tank.
