4. Details of our assessment

A site visit was carried out on the 29th July 2026.

NRW officers attended and met with the Grounds and Maintenance supervisor.

Officers visually inspected the package treatment plant (PTP) and the drainage field as well as the 4 pumping stations on site. No issues were found.

Grounds and maintenance will check the PTP every morning to ensure the interior wheel is turning.

The PTP and pump stations are all fitted with lights and alarm sirens if there is an issue.

The treated effluent is then pumped out to a drainage field. The drainage field was visually inspected and there was even greening across the site, suggesting it is free from blockages.

There are hot tubs on site but it was confirmed that these are not emptied into the PTP.

Action: please transfer the permit to the correct business name. Operating and discharging without a valid permit is an offence under the Environmental Permitting Regulations 2016.
