4. Details of our assessment

This Compliance Assessment Report is being produced following a report received by Natural Resources Wales of odour in the vicinity of North Powys Bulking Facility.

The site was visited by the site officer, Luke Taylor (Senior Officer - Waste Regulation) of Natural Resources Wales, and Gillian Coates (Hazardous Waste Regulation Officer) on Wednesday 22nd July.

The weather at the time of the inspection was warm and dry, the wind direction was from the North East, and the site was operational.

The officers were accompanied by site supervisors throughout.

W3C Odour - Permit Condition 3.2.1

Prior to attending the site on the above date, the officers conducted an odour assessment to the North of the site boundary, on the access road leading off the B4386 into the estate. No odour was detected over a period of five minutes.

The officers have then attended the site and spoken with site supervisors. There were a significant number of vehicle movements occurring, with waste being tipped by municipal waste refuse wagons returning to site. The doors to the transfer building were being opened and closed to facilitate this, being closed once a vehicle was inside the building, in line with the site odour management plan.

The officers conducted further odour assessments outside of the South boundary to the site. No odour was detected.

On leaving the site, an odour assessment was conducted on the West boundary, adjacent to the B4386. No odour was detected.
