4. Details of our assessment

NRW have carried out a data audit of the Ganol Wastewater Treatment Works Permit

CG0377601.

Below is a summary of NRW's findings using the information DCWW provided.

Data range 1 – 4

1. 24/5/24 EDMS spill for 8.5 hours. Average FPF was 153 l/s below resulting in a discharge in breach of ~ **11 million litres**
2. 18/11/24 EDMS spill for 13.5 hours. Average FPF was 62 l/s below resulting in a discharge in breach of ~ **3 million litres**
3. 17/9/25 EDMS spill for ~3 hours. Average FPF was 150 l/s below resulting in a discharge in breach of ~ **1.7 million litres**
4. 11/2/26 EDMS spill for ~ 26 hours. Average FPF was 65 l/s below resulting in a discharge in breach of ~ **5.7 million litres**

From data provided by DCWW for the period 16/04/24 to 11/05/26, the EDMS was registering spill events for a total of 1800 hours. During the four periods above, the average FPF was operating 107l/s below its permitted requirements of 500l/s. Therefore, for the total estimated discharge for the whole data set is 693,360,000 litres in breach of permit.

The formula NRW use to calculate these figures is the following

Volume discharged in breach of permit = 1800 EDMS x 60 minutes x 60 Seconds x 107l/s

$1800 \times 60 \times 60 \times 107 = 693,360,000$ litres
