4. Details of our assessment

This Compliance Assessment Report (CAR) has been completed following review of the Q2 2026 (April to June 2026) monitoring returns submitted by RWE Generation UK plc for Pembroke Power Station, West Pennar, Pembroke, Pembrokeshire, SA71 5SS, regulated under Environmental Permit EPR/DP3333TA.

Q2 2026 Monitoring Returns

The quarterly monitoring returns for emissions to water and emissions to air were submitted to Natural Resources Wales on 20 July 2026. The returns were submitted within the required reporting period specified by permit condition 4.2.3 and Schedule 4 of the permit. All data was provided using the appropriate permit reporting forms.

Emissions to Water – Water 1 Return

The Water 1 return covering emission points W1, W1(a), W1(b), W1(c) and W2 has been reviewed against the requirements of Table S3.2 of the permit. Reported flow, temperature, temperature differential, pH, total residual oxidant and oil and grease monitoring results were within the applicable permit emission limit values. No permit exceedances or other non-compliances were identified.

Emissions to Air – IED/LCPBREF CON2 Return

The IED/LCPBREF CON2 returns for LCP286 (Unit 11), LCP382 (Unit 21), LCP383 (Unit 31), LCP384 (Unit 41) and LCP385 (Unit 51) have been reviewed against the emission limit values specified within Table S3.1a of the permit. Reported NO_x and CO concentrations remained below the applicable permit limits for all units. No permit exceedances or other non-compliances were identified.

Monitoring Issue Notification

On 18 May 2026, the operator notified NRW that its external laboratory provider (ALS) was unable to report a nitrate result for the April 2026 W1(a) Water Treatment Plant effluent sample because the sample was deemed insufficient for analysis. The operator advised that a formal complaint had been raised with the laboratory and that an investigation was underway. The operator also stated that notification from the laboratory was not received in sufficient time to enable a resample to be undertaken within the relevant monitoring period.

NRW notes that the matter was proactively reported by the operator and that the missing result was attributed to a laboratory sampling/analytical issue. The operator has provided an explanation for the omission and no further regulatory action is required at this time. The missing nitrate result has been noted during the review of the Q2 2026 Water 1 return.
