4. Details of our assessment

A routine effluent sample collected from Tanygroes Sewage Treatment Works (STW) on 24 February 2026 was found to contain 117mg/l Suspended Solids. As per permit condition 4(d)(ii) on Tanygroes' permit, the discharge shall contain no more than 30mg/l Suspended Solids.

Dŵr Cymru Welsh Water (DCWW) submitted a Stage 1 Appeal on 20 April 2026 regarding the sample result obtained on 24 February 2026. DCWW raised a number of concerns, including the relationship between the biochemical oxygen demand (BOD) and total suspended solids (TSS) results, the consistently good operational sampling results recorded before the failed sample, and the fact that the operational team did not identify any indications of poor performance during the routine site visit undertaken on 24 February 2026.

Following a review of the information provided by DCWW, together with information held by Natural Resources Wales (NRW), there is sufficient uncertainty for NRW to say that the sample result obtained from Tanygroes STW on 24 February 2026 was representative. As such, NRW will remove this result from our compliance assessment.

We have carefully considered the points raised in relation to the BOD:TSS ratio. Following consultation with our laboratory specialists, we are satisfied that the BOD:TSS considerations presented in the appeal are not applicable in this particular case.
