4. Details of our assessment

On the 21 July 2026 NRW received a report of odour being generated from your site.

NRW Officer Shaun Rees made you aware of the complaint, of which you recorded, investigated and provided the requested Odour management plan. In your response to the officer regarding the investigation, you found no operating failures on site and stated that the ventilation fans had been working at a higher capacity than normal due to the heatwave.

On the 27 July 2026, Officer Rees carried out an odour assessment of the area.

Assessment was carried out during dry weather, with a slight South Eastly wind, the assessment was carried out at a number of locations surrounding the poultry site and no poultry odour was noticed.

Slurry spreading was taking place, in fields adjacent to the poultry site.

It was decided by the attending Officer, not to visit the site itself, due to already attending another poultry site that morning, and would increase the risk of biosecurity.

No further action required.
