4. Details of our assessment**Withyhedge Waste Transfer Station QP3098FL**

Resources Management (UK) Limited (RML) operates Withyhedge Waste Transfer Station (WTS) under the provisions of an EPR Permit (QP3098FL). The WTS accepts waste ahead of disposal within Withyhedge Landfill (MP3330WP).

Purpose of Compliance Assessment Report

An unannounced inspection of the WTS was performed by NRW officer on the 14th July 2026.

Inspection included observation of the following:

- Incoming waste at the Waste Transfer Station (WTS) operating under environmental permit QP3098FL.

Waste Transfer Station Observations

Waste being deposited at the WTS was classified as 19 12 12 - Shredded general waste. NRW officer was satisfied the waste met this description and therefore classified correctly. During the inspection all five waste bays were at capacity,

Wastes delivered on the 14th July 2026 included, waste accepted under the WTS permit (QP3098FL) before being deposited within the landfill, and waste accepted under the landfill permit (MP3330WP) deposited directly to the landfill cells.

NRW officer completed an independent visual inspection of the tipped waste. No evidence of any banned or prohibited wastes were observed. No associated odours were detected whilst inspecting the waste.

During the inspection, a considerable number of seagulls were noted at the WTS. A pest controller was observed operating in the area, the bird of prey was being flown above the landfill and WTS to act as a deterrent.

The extended period of dry weather and constant vehicle movements is creating significant amount of airborne dust in the WTS, operator implementing measures to manage fugitive dust levels by dampening with water.

Waste Transfer Drainage

Construction work has begun to install a closed drainage system at the WTS. The concrete drainage channels have been delivered to site.

Excavation aspects have been completed, NRW officer observed part of the channel being appropriately located. It's predicted the construction work will remain ongoing over the coming weeks.



Due to health and safety concerns, the weighbridge has been deemed unsafe to use due to the drainage alterations. Weighbridge has been non-operational since the 7th July 2026. Operator outlined the procedure being implemented on site to manage and record arriving waste, operator expects weighbridge will be reinstated on 20th July.
