4. Details of our assessment

This Compliance Assessment Report (CAR) details the comments of Natural Resources Wales (NRW) Officers for the site inspection conducted on 10 August 2026 at Swan Alloy Wavernarlwydd Works, Wavernarlwydd, Swansea, SA5 4SF.

The purpose of the visit was to assess fly activity at the site following previous reports of fly nuisance within the Wavernarlwydd area, where the Swan Alloy site is located.

Site Observations

The site contained bales of aluminium cans stored within the designated storage areas. These cans (and other aluminium scrap) are used in the site's process for producing reusable aluminium.

Fly activity was significantly lower than that observed during the previous site visit. A small number of flies were present on one load of cans, which site personnel advised were scheduled to be processed shortly. No significant fly activity was observed in the majority of areas where baled cans were being stored.

The site has maintained good house keeping in the waste storage areas and fly trap bags were in place at numerous locations. A number of flies were seen within the fly trap bags which were being replaced shortly. The site confirmed they continue to manage pests such as flies with ongoing prevention and mitigation measures such as:

- Waste acceptance procedures - visual inspections of incoming waste for fly activity being undertaken as well as standard quality assurance checks. If fly activity is observed, appropriate action will be taken e.g reject the waste or process within the furnace as quickly as possible.
- Waste storage - higher risk wastes that may attract flies have been located further away from nearby receptors. Quarantined wastes were also clearly visible and labelled.
- Ongoing engagement and utilisation of their pest controller specialist - This includes weekly attendance to site and weekly spraying of waste to control fly activity. The site's appointed pest controller also replaces the fly trap bags when required.
- Monitoring - The site's TCM undertakes regular fly monitoring.
- Pest Management Plan (PMP) - The operator shared a copy of the draft revised PMP. The updated PMP appeared to contain more detailed information in line with NRW's expectations for a PMP. The revised PMP will be submitted within the next 2 weeks.

Pest management measures including the use of the pest control specialist and weekly spraying appear to have been effective in the prevention and management of flies. Such measure should continue to be implemented at the site when deemed necessary.

No fly infestations were seen on or offsite.
