4. Details of our assessment

Resources Management U.K Limited (RML) operates Withyhedge Landfill under the provisions of an EPR Permit (MP3330WP). The Site is a non-hazardous landfill which has been constructed in two phases. Phase 1 accepted waste from 1985 until its closure in 2006. Phase 2 is where the current active tipping area is found at the Site, specifically Cell 10.

Introduction

An unannounced site inspection was undertaken on 14th July 2026 to assess the progress of landfilling activities.

Site Operations

Landfilling activities were located within the valley between Cell 9 and Cell 7 and also in Cell 10B. During the inspection of the active tipping area, officer observed no evidence of banned or prohibited waste types. Tipped waste in the valley between Cell 9 and Cell 7 was being compacted creating access route to Cell 8.

An intermediate cover layer was present across the uncapped areas of sub-Cell 10B. The cover material appeared to be a cohesive, low permeability soil, considered suitable for use as intermediate cover, and is listed within Cell 10's approved waste phasing plan.

A pest control contractor (Hawk) was present during the inspection. The bird of prey was being flown above the landfill to act as a deterrent. Despite this, pest volumes was considerable during the time of the inspection.

Basel liner and Geotechnical membrane being installed in Cell 11. Heavy plant preparing and contouring areas in preparation of future cell constructions.

Construction of the waste transfer station drainage system has begun (4th July). Pit has been excavated and concrete channels observed being installed. Due to health and safety concerns, the weighbridge has been deemed unsafe to use due to the drainage alterations. Weighbridge has been non-operational since the 7th July 2026. Operator has outlined the procedure being implemented on site to manage and record arriving waste, operator

expects weighbridge will be reinstated on 20th July.

Landfill Gas Management

During the inspection two landfill gas engines were operating normally, in conjunction with gas flaring. No issues were reported with the landfill gas collection system. Gas flow rate entering the compound was at an estimated 1650m³/hr

Hydrogen sulphide (H₂S) concentrations being extracted from Cell 10 were recorded at approximately 1750 ppm. Cell 9 concentrations at 895ppm and cell 8, 215ppm.

Waste Acceptance – Waste Transfer Station (WTS)

Officer observed several vehicles being unloaded within the WTS and subjected to Level 3 Verification Testing. During the inspection all 5 waste bays were at capacity, waste appeared to be shredded general mixed waste, which is listed within the EPR Permit's for both the landfill and WTS (QP3098FL).

NRW officer completed an independent visual inspection of the tipped waste. No evidence of any banned or prohibited wastes were observed. No associated odours were detected whilst inspecting the waste.
