3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 26th February 2026, DCWW submitted Dry Weather Flow data for 2025, as required by the permit. The submission for this site contained erroneous data and the correct data was then submitted on 29th July 2026. This delay is a breach of permit condition 4.2.2 :

Within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit

More than 14 consecutive days and over 37 days in total of the 365 daily volume readings were not 'Good' readings. This is a breach of permit condition 3.3.10 (c) :

There shall be no more than 37 days and/or no more than 14 consecutive days with 'suspect' or 'missing' Total Daily Volumes in a calendar year, unless otherwise agreed in writing by the Natural Resources Wales.

These breaches are in contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 which states that it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

A warning for this non-compliance has been issued with this Compliance Assessment Report (CAR).

DCWW informed NRW that the cause of the poor data was linked to a '*media release that occurred on 25th September 2025 the MBBR flow monitors were damaged, and the data wasn't accurately recording, and the flow monitors were replaced so we've invalidated all data from then*'.

DCWW also informed NRW that the meters are currently working correctly (5/8/26).

Actions :

1) Provide details regarding steps taken to ensure any future data which is invalidated is carried out prior to the annual submission. i.e. was it possible to identify the data being problematic in the period prior to 28th February 2026.

2) Ensure the flow monitor is operational and recording flow data as required. **This action has already been completed.**
