4. Details of our assessment

Coastal Oil and Gas Limited – EPR/JB3993HS

Waste Regulation Officer Daniel Hopkin and Gareth Morris attended the permitted site of Coastal Oil and Gas Limited, Land off Tyla Lane, Merthyr Mawr, Bridgend, CF32 0FL on the 17th of August 2026. Coastal Oil and Gas Limited currently hold a bespoke permit for mining waste operations for the management of extractive waste not involving a mining waste facility. This was a planned inspection of the site with the permit holder as they are considering applying to surrender the permit for the site.

We were met by the permit holder who showed us around and answered any questions. The weather was dry on the day of inspection. We arrived at 11:50.

There were no breaches recorded during the visit.

During the inspection, the permit holder explained that the site has remained non-operational since the permit was granted and this site is no longer being considered to carry out works at therefore a surrender is necessary.

No waste was present on site, and there was no evidence of contamination, pollution, or any illegal activity. The site appeared to have remained undisturbed by the company, as seen in the photo below.



I would anticipate based on the site inspection, that EPR/JB3993HS should be considered a non-operational surrender however as a reminder, this is guidance only and the Natural Resources Wales waste permitting team will determine the actual type of surrender.

There are no outstanding actions or breaches in relation to this permit.
