4. Details of our assessment

This compliance report is based on a site visit carried out by NRW on 04/08/2026. The weather on the day of the inspection was clear and sunny, and there had been little to no

rainfall in the preceding weeks.

At the time of the inspection, additional aeration was being provided to the aeration ditch while repairs to the system were underway (as shown in the figure below). The operator stated that the sludge tank is emptied every 6 to 8 weeks.

During the visit, no other issues were noted, and all system components appeared to be in good working order, with the exception of the aforementioned aeration repairs. In addition, the DCWW sampling point was inspected, and no issues were identified.

This site is compliant with its environmental permit and no further action is required.
