4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the **Q1** (January - March) and **Q2** (April - June) 2026 monitoring returns by Dunbia (UK) (the operator) for activities at Teify Park Abattoir and Meat Processing Plant, Lampeter Road, Llanybydder SA40 9QE under Environmental Permit EPR-BV9683IH.

Q1 and Q2 2026 Monitoring Returns**Emissions to water** – *Q1 and Q2 Water*

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to discharge point **W2** for:

- **Q1** (1 January - 31 March 2026), and
- **Q2** (1 April - 30 June 2026)

were submitted to NRW on 20 April and 14 July 2026, respectively.

The parameter listed for emissions to W2 were:

(i) Total suspended solids, (ii) pH, (iii) BOD, (iv) Ammonia, and (v) Volume/Flow rate.

- The monitoring data was sent within the **Q1** and **Q2** reporting periods, which is compliant with permit condition 4.2.3.
- The monitoring was conducted inside the **Q1** and **Q2** monitoring periods, which is compliant with permit condition 3.6.1.
- The monitoring returns submitted includes reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1 of schedule 4, which is compliant with the environmental permit.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified limits over the **Q1** and **Q2** 2026 reporting periods.

Quarterly Waste Effluent Inputs to ETP - *Form 4.2.5*

These documents were submitted to NRW on 20 April and 14 July 2026.

- This data was sent within the reporting periods, which is compliant with permit condition 4.2.5.
- The reports details a NIL return.
- Based on the report submitted by the operator, the waste data appears **compliant** with the

specified permit requirements over the **Q1** and **Q2** 2026 reporting periods.
