4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 04/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14 May 2026

The 14-day clarification note has been embedded into our process when completing programme amendments. The first "additional" date may not comply with this and fall within the 14-day period, as we always try and complete the change without delay. This has been accepted by NRW however, dates that have been provided for samples already taken are not acceptable and we have endeavoured to comply with this. No further instances have been recorded of providing dates that have already taken place.
